

# COUNCIL OF NORTHERN CAVING CLUBS

## ANNUAL GENERAL MEETING

Minutes of the annual general meeting held on Saturday 14th February 1987 at Ingleton Community Centre.

Meeting started at 2pm chaired by D. Leonard.

- 2) APOLOGIES FOR ABSENCE: None
- 3) MINUTES OF LAST MEETING: Taken as read (previously circulated).
- 4) MATTERS ARISING: P Muckalt questioned item (12) regarding schools and outdoor centres. P Ramsden indicated that policy had been discussed and that the current position was that it was not the desire of CNCC to constantly check and vet the leaders of these groups. The chairman said that the situation would be kept under review.
- 5) OFFICERS REPORTS: Chairman; Previously circulated. The chairman reiterated his ideas on travelling expenses for officers. The feeling from the floor was that if expenses were granted to officers it was only fair to include all committee members and field secretaries. In view of the large expense of such a move the chairman dropped his proposal.  
Secretary; Previously circulated  
Treasurer; Previously circulated. The committee proposed an increase in annual subscriptions to £7. The view was expressed that this was a large "all in one go" increase. It was also felt that £7 was not enough as reserves were very low and no money was available for contingencies, the lack of finance was also preventing CNCC from taking more positive initiatives. Craven Pothole Club proposed that subs be increased to £10 per annum, this was seconded by Red Rose, the proposal was carried 6 for, 4 against. Annual subscriptions from 1988 will be £10.  
Access and Conservation; i) Casterton Fell. Negotiations have now been in progress since February 1984, with little progress. The land agents want CNCC to levy a charge of £2 per caver per trip. They are concerned about the increased number of people using the fell and claim that higher levels of access are affecting sporting rights. P Muckalt pointed out that there was increased pirating of the caves and that the number of permits issued had increased only slightly. Using



Using current figures a charge of £2 per head would generate an income of £5-6,000 per annum. Leaving aside the desirability of such a charge it was felt that it would be impossible for

CNCC to levy such a fee; ie if people paid in advance what about poor weather, changing numbers etc etc. Apart from these considerations it was stressed that cavers would not be prepared to pay £2 per trip and a dangerous precedent would be set. In a letter to the chairman Jim Davis suggested that a 20p payment similar to that at Alum Pot for the upkeep of footpaths, walls etc might be acceptable. The following motion was proposed by CPC and seconded by DHSS:- "That CNCC does not accept the system of collecting £2 per head", the proposal was carried unanimously. Lengthy discussions followed as to the course of action to take having rejected the land agents proposals. A number of ideas were talked over including negotiating open access, apply to make caves public footpaths involving the Ramblers Association and buying or leasing the land as the BMA has done with certain crags. It was felt that a leasing arrangement or one of payment for maintenance of access might be acceptable. The meeting left the matter in the hands of the officers and committee to continue negotiations. At present however CNCC has notice that its access agreement on Casterton Fell will be terminated as from April 5th 1987. The meets secretary for Casterton Fell will write to the clubs holding permits for after April 5th informing them of the situation. In the meantime for any clubs wanting permission to go caving on Casterton Fell after April 5th 1987 this is the address to write to: Davis and Bowring

The White Scar management have submitted a planning application to extend the show cave by boring a tunnel to beyond the battlefield. Some discussions on the matter resulted in the following conclusions; 1) by bypassing the battlefield the extension would in effect help to preserve this delicate part of the cave. 2) the access and conservation officer would write objecting to any dumping of spoil in the lakes ie all the spoil should be taken out of the cave. 3) access should be maintained for cavers into the far reaches of the system. - ii)Leck Fell: no permits left for weekends up to the close season. On the 31st December 1986 the entrance to Notts Pot collapsed, it is still blocked.
- iii)Casterton Fell: report enclosed. Too many examples of pirating. It is intended to put a moveable grill over the entrance to Link and Mistal to prevent sheep going caving.
- iv)Birks Fell/Mongo Gill Report enclosed.
- v) Pennyghent: Number of requests for permits down, possibly because of more pirating eg Leeds University rescue incident. If pirating continues any more incidents will lead to access problems. This area has the same land agents as Casterton Fell..

CHAIRMAN'S REPORT FOR 1986

~~In fact~~

In several respects, 1986 has been a disappointing year.

Much time at the six committee meetings has been spent on the ~~an~~ vexed question of pirating - about which there seems very little we can do short of expelling member clubs - several of whom are reluctant to pay their annual dues promptly.

No doubt our Treasurer will report on the financial situation and it would seem one way to save administration costs will be to reduce meetings from the current total of six to the constitution minimum of three.

Despite <sup>the</sup> strenuous efforts of our Access & Conservation Officer and area Meets Secretaries, our attempts to sign new access agreements for both Leck and Casterton Fells have not - so far - proved successful.

We are continuing to issue permits in the spirit of the lapsed agreements although some clubs/cavers seem to think they have free access to these sensitive fells. This does not help the situation.

I have suggested that the Council may agree in principle to pay a contribution towards Officers travelling expenses - assuming the Council is on a sound financial footing. It is my considered opinion that one of the main reasons why voluntary organisations such as ours have difficulty in filling committee places is the not inconsiderable cost of attending meetings. Those of us who represent small clubs are unlikely to obtain financial assistance from their clubs - I hope larger clubs subsidise their representatives.

This <sup>still</sup> brings me to the subject of the annual subscription which, for 1987 is the paltry sum of £4.00. A proposal will be put to the next A.G.M. to increase this to a <sup>more</sup> realistic figure.

I regret that this Council does not have the manpower to adequately attend the regular meetings of the National Caving Association. If the ongoing discussions on the future of our National body result in an organisation where any caver can express any relevant opinion this can only be to the good of the future of Caving in this country.

Applications for membership are buoyant with an average of 3 or 4 per meeting which shows continued support of the C.N.C.C. organisation and its policies, it's nice to think that you are giving up your free time for a useful purpose.

C.N.C.C. CONSERVATION & ACCESS OFFICER'S REPORT 1986/87.

During the year I have maintained close liason with the Nature Conservancy Council, particularly the regional office at Leyburn and their Chief Geologist Dr Richards from Peterborough. It is hoped that this close liason will prevent a situation, like that which occurred on Mendip, from developing. Contact, advice and comments were made on the following sites where problems had arisen concerning SSSI boundaries or problems with farmers and land owners.

Clapham Cave(May)  
Upper Nidderdale(Aug)  
Boreham Cave(Aug)  
Whernside(Sept)

Birks Fell Cave(Oct)  
Ingleborough(Nov)  
White Scar Cave(Dec/Jan)

The only ones causing major concern were Clapham Cave(proposal to build a flood control gate) and White Scar Cave(planning permission application to construct a tunnel to extend the show cave). Both of these are being thoroughly investigated by the N.C.C. since I and other cavers have lodged objections. They need careful thought if the caves are to be properly conserved. I have more details if people want them, including the White Scar planning application. I continued N.C.C. liason at the BCRA Conference where I attended the SSSI debate with Dr Richards.

I have attended a couple of N.C.A. C&A meetings during the year. Pete Mellors from DCA has now replaced Howard Jones on the Cave Conservation Emergency Fund Committee. The NCA will soon publish a "Legal Aspects of Access Underground" booklet. Both cavers and landowners should find it a useful guide to how the law relates to access, liability and conservation.

Casterton Fell negotiations:- After over a year of not hearing from the agents for Casterton Fell, on 10th Jan I received a letter from Davis & Bowring. They wanted to know if the C.N.C.C. was prepared ... "to levy a charge of £2 per person going caving on the Fell." He only gave me a week to reply. I sent a rather terse letter in which I explained that we would need a C.N.C.C. meeting and that it would take time to set up. On 21st Jan I got a letter terminating the licence as from 5th April, unless we satisfied his wishes by that time. Since then I have spoken on the phone to him to try to arrange a meeting but he refused as he said there was nothing to discuss until we had some proposals on how we intended to collect the money. Here the situation stands at present. It is up to the A.G.M. to decide how we proceed from here. But remember the payment of any money would set a damaging precedent in British caving.

(Most pirates go this way as well as via Bull Pot Farm).



## ANNUAL REPORT

### Meets Sec. Ribblesdale

276 permits were issued which was 40 less than 1985.

1986 has been marred by access problems, arising out of rescues due to cavers entering potholes in less than stable weather conditions.

Early in the year rescues at Hammer Pot and Gingling Hole resulted in the farmer wishing to close the fell. This was avoided after considerable efforts by both the CNCC and CRO, and at the cost of a reduced open season and many hours of voluntary work by CRO mending the track. Further the CNCC is committed to rebuild the bridge near the shooting hut. This work is being undertaken by the Earby P.C., the Y.S.S. and the B.P.C.

Later in the year a rescue in Peny-gent Pot caused by flooding endangered access to the area. Again the main cause of concern by the Land agents was cavers going underground when heavy rain was forecast. The fact that they didn't have a permit made matters worse. The situation was rectified only after a lot of persuasion by CNCC and a good deal of embarrassment to the full member club concerned.

All the major potholes in the area are seriously affected by flooding and can become impassible in a matter of minutes.

### Meets Secretary's Report for Birks Fell and Mongo Gill

#### General

The change of Meets Secretary in December 1986 appears, so far, to have caused few problems. Hopefully the recently issued updated address list will assist.

In line with Council policy I have declined to issue permits to clubs who have not yet paid their 1987 subscriptions. This is causing some additional work in explaining why permits are being withheld, plus the extra workload for our Treasurer in keeping all concerned aware of the latest subscription payments. Hopefully the system is producing the desired results.

Despite my brief spell in office may I repeat the time honoured requests for clubs to enclose a Stamped Addressed Envelope with all correspondence. Failure to do so will mean permits being despatched in an unstamped envelope and I accept no responsibility for the additional expense this may cause, or for any delay. Last but not least will club meets organisers check that the dates they request do not fall within the 'Closed Season'.

#### Birks Fell

No access problems to report.

Of the 56 weekend days available during the 1986 season, 41 were booked. In addition 14 mid-week permits were issued.

For the record a look back through previous years bookings shows the following information on permits issued per year:

1977 - 32	1981 - 50	1984 - 63
1978 - 35	1982 - 47	1985 - 46

The situation at 13th February, for the current year was 30 bookings confirmed, of which 5 are mid-week. Dates are still available, mainly for the period late July to end of October, for any interested club (assuming they have paid their subs.)

#### Mongo Gill

Again no access problems to report.

Permits issued for 1986 were 28 to a total of only 14 different organisations. 25% of these bookings were for mid-week. Again a brief breakdown of previous years bookings is as follows:

(Earliest traceable record was 1977 when only 7 permits were issued)

Bookings at 13th February for 1987 were 25, 18 of which were mid-week. Again plenty of dates available for interted groups.

REPORT OF CNCC. REP. ON N.C.A. TRAINING COMMITTEE

There have been 3 main areas of interest:-

I. Local Cave Leader & Cave Instructor training & assessment.

Most time has been spent on this to ensure continuity of existing schemes after Whernside ceased involvement. It is stressed that these schemes are aimed only at those taking responsibility for others. L.E.A.s and employers need some standard to apply for leaders of organised parties & it is important that such schemes are controlled by cavers rather than employers. Equally, approved leaders who are acting as our ambassadors representing the image of caving to beginners must have credibility with cavers.

In this area the Northern England Local Cave Leader Panel has been set up for interested organisations, so that they do not have to operate in isolation and to ensure consistency of standards. A seminar for trainers and assessors was held at Whitehall centre from 21-23 Nov. Methods of training and assessment, and validating assessors & schemes were discussed. A report will be available shortly.

2. Caver Training.

The Training Committee think that training for cavers should be available, particularly in modern techniques. Because nothing specifically has been organised less time has been spent on this topic, this is no reflection of its relative importance.

3. The grant submission to the Sports Council on Training

This will dictate what happens in future. Two full time training-co-ordinators are proposed and a peripatetic training scheme. Leaflets are available on "So you want to go caving" for the novice also "Courses for novices/cavers/cave leaders"

I attended a meeting of the grant-aid Working Party to consider setting up a system to look into possible restructuring of a national body for caving.

The likely course of action is for N.C. A. to publicise an analysis of the current functions & structures, possible alternatives with a case for and against each. It will make it known that the Working Party exists, and what representation on the W.P. is. (Possibly two Reps. per constituent body-ideally with different opinions? , maximum consistency of attendance at W.P. meetings, Reps. gathering information however possible through their constituent bodies.) Nothing was finalised, the next N.C.A. meeting will decide.
